



Public Market Performance

In Q4 2021, public equities across many of the Industrials sectors performed in line with the broader U.S. equity market and were near all-time highs. Some of the stronger performing individual companies have been managing effectively against rising costs, supply chain challenges, and labor constraints. Over a 3-year period ending 12/31/21, the S&P 500 has returned 88.2%. Building Product Distributors saw a substantial increase in Q4 stock performance due to stronger than expected demand and have outperformed the S&P 500 with a return of 211.2% over a 3-year period. Automotive Manufacturers and General Industrial Manufacturers have also performed well over the past three years, recording gains of 108.0% and 105.7%, respectively.

Industrial Sector Market Performance








Middle-Market M&A Activity

The volume of M&A activity in the Industrials sector increased significantly in Q4 2021 with 366 deals closed, compared to 300 during the previous quarter, continuing the historic pace of M&A activity during 2021. Average deal value (based on reported transaction value) declined which suggests a strong increase in activity throughout the middle market area. Strategic buyers continue to represent the largest percent of the transactions and have sought acquisitions to add more products, services, and technological capabilities while strengthening their market share. The General Industrial Manufacturing category led M&A activity, accounting for 30.9% of total transaction volume. Polymers, Chemicals & Plastics Manufacturing deal activity remained strong with 22.4% of transaction volume.

M&A Activity by Buyer Type



Public Company Trading Multiples

Based on a representative set of publicly traded companies in the Industrials sector, public companies traded at an average multiple of 14.5x EBITDA and 2.4x Revenue. Additionally, one of the strongest market segments in the Industrials sector was Aerospace & Defense Manufacturing with a median multiple of 13.2x EBITDA. General Industrial Distributors also performed well, recording a median multiple of 11.9x EBITDA at the end of Q4.
