

Market Commentary


The 737 MAX was recertified by the Civil Aviation Administration of China (CAAC) allowing for a return to service in the country. Boeing is currently producing the 737 MAX at a rate of 26 aircraft per month and continues to expect a previously stated target of 31 per month. Boeing reported an inventory on the aircraft of approximately 335 at the end of the fourth quarter.

The \$768 Billion 2022 National Defense Authorization Act (NDAA) was passed in Congress and signed by President Biden, however the NDAA does not authorize funding until Congress passes a wider appropriations bill for FY2022. A continuing resolution remains in effect for fiscal 2022 with a current expiration date of February 18th.




