



Recent Market News / Developments

- On Jan. 5, an Alaska Airlines Boeing 737 MAX 9 experienced a "plugged" emergency exit door flying off mid-flight, prompting a series of quality and process examinations
- The US Army announced that it will halt the Future Attack and Reconnaissance Aircraft (FARA) program, redirecting funds to expedite the upgrade of Boeing Chinook CH-47s while maintaining plans to develop new attack helicopters and next-generation unmanned aircraft by 2030
- Ethiopian Airlines signed an MOU for eight 777-9s, with the potential to expand this to 20 aircraft
- The 2024 Defense budget was signed into law on March 25 at \$825 billion of total funding, after months of operations under a continuing resolution
- The Defense Department made an initial \$850 billion request for fiscal 2025













